

TERMS AND CONDITIONS

North bar/ICBM/Meche

Confirmation

Your booking will be secured when a deposit of \$500 has been received with a completed and signed booking form a minimum of 14 days prior to function. Deposits can be paid by cash or credit card. A valid credit card number must be left with management at time of booking. Food menu selections must be confirmed 14 days prior to the function.

Cancellation

If a cancellation is made:

- Two weeks prior to the function, the 50% of the deposit will be reimbursed.
- Less than two weeks notice, North/ICBM/Meche will retain the deposit. And charge the remainder of the minimum spend to the credit card.

Payment

Payment of bar tabs and food can be paid on or before the date of the Function. Full payment of minimum spend must be made before the function commences. Minimum Spends must be adhered to. Payment can be made by cash or credit card. When bar tab does not reach the minimum spend required no refunds of differences will be made.

Insurance/Damage

Our organization will take reasonable care, but will not accept responsibility for damage to or loss of items before, during or by your guests after a function. You are financially responsible for any loss or damage sustained to the premises or our property during a function or by your guests when entering or leaving the premises. You are also responsible for any loss or damage to equipment hired by us for you.

Age restrictions

As these are licensed premises all patrons of the function must be of 18 years or older. However in accordance with ACT liquor licensing laws minors are allowed if they are strictly supervised by their legal parent or guardian. Sufficient identification must also be provided to PROVE legal responsibility of children. Appropriate identification is the sole responsibility of the legal parent or guardian. Failure to comply will result in denied entry.

Any minors caught drinking alcohol will be removed along with their legal parent or guardian and reported to police.

(Please note: Legal means LEGAL. Uncles, siblings, friends etc... do not qualify as a legal guardian!)

Dress Code

During 6pm-10pm our dress code is relaxed and we do accept tasteful fancy dress between these times. However, our dress code does apply after 10pm when we admit the general public. Please take this into consideration as you may need to bring a change of clothes.

Other

The client shall conduct the function in an orderly manner and in full compliance with the rules of North/ICBM/Meche management and in accordance with all applicable laws. The client is responsible for the conduct of the guests and invitees and indemnifies North/ICBM/Meche for all costs, charges, expenses, damage and loss caused by any act or omission by the client, client's guests or invitees.

No food or beverages of any kind is permitted to be brought to the function by the client, client's guests or invitees, unless prior permission has been obtained. North/ICBM/Meche reserves the right in its absolute discretion to exclude or remove any undesirable persons from the function or North/ICBM/Meche premises without liability. Management reserves the right to close the bar when it deems necessary.

North/ICBM/Meche reserves the right to cancel the booking if:

- North/ICBM/Meche or any part of it is closed due to circumstances outside the establishment's control.
- The client becomes insolvent, bankrupt or enters into liquidation or receivership.
- The function might prejudice the reputation of North/ICBM/Meche.
- The room hire and food has not been paid by the due date.
